The applicant agrees to observe and obey all Parks Rules and Regulations to include the following:

- Fees for non-residents of the incorporated and unincorporated areas of Beavercreek Township will pay in advance to the City of Beavercreek Parks, Recreation & Culture Department a fee of \$10 per campsite per day for up to \$30 maximum per campsite
- Camp fees are waived for non-profit charitable organizations
- Permit holder must have a copy of the agreement/permit onsite during entire rental
- Use access road to drive to campsite, please do not drive on the grass
- Use of alcoholic beverages prohibited
- Maximum of four (4) tents per campsite is permitted
- Maximum of two (2) cars allowed at each campsite.
- No littering. Bring your own trash bags, and take trash with you when you leave.
- Open fires permitted only in the fire pit and standing grill
- Tent camping only. Van/Camper/RV Camping is not permitted
- In case of emergency, call 911

**Waiver of Liability:** In consideration of you accepting my reservation for a City of Beavercreek Parks, Recreation and Culture facility, I hereby, for myself, my child, my heirs, executors and administrators, waive and release any and all rights and claims for damages I or my child may have or may acquire in the future against the City of Beavercreek, Beavercreek Township Park District and its representatives, successors and assigns for any and all injuries suffered by myself or my child in connection with the said reservation(s). I do hereby grant and give these groups the right to use my or my child's photograph or image with or without my child's name, both singly and in conjunction with other persons or objects and presentations, advertising, publicity, and promotion relating thereto. I warrant that I have the right to authorize the foregoing uses and do hereby agree to hold the City of Beavercreek, Beavercreek Township Park District and its representatives, successors and assign harmless of and from any and all liability of whatever nature which may arise out of or result from such reservation(s). For the consideration stated above, I further agree that in the event that my child repudiates or attempts to repudiate such release, I will personally indemnify and save

harmless the City of Beavercreek Parks, Recreation and Culture Department, its successors and assigns, for any and all loss and damage occasioned thereby.

**Terms & Conditions:** This Agreement, when signed by the applicant and a representative of the Beavercreek Parks, Recreation and Culture Department constitutes a contract binding both parties to certain obligations. The applicant agrees to observe and obey all Parks Rules and Regulations, the City of Beavercreek agrees to maintain the facility, to assure that the facility is prepared properly for the agreed-upon event, and to provide adequate sanitation facilities, subject to available equipment, resources, weather conditions and time of year.

**City of Beavercreek and Beavercreek Township Park District policy prohibits restricting or limiting facility use and access on race, color ability, religion, sex, age or national origin.**

**Please adhere to all Park Rules & Regulations, especially Section 171.06: Fires.**

- a. No person in a park shall start or maintain a fire except in a place or at a site designated for this purpose. A person who starts or maintains a fire shall see that it is properly contained and extinguished before leaving
- b. No person in a park shall collect wood in the park for any purpose. You may bring in your own wood for fire making purposes
- c. No person in a park shall place portable stoves or grills in shelters or on combustible picnic tables
- d. No person in a park shall deposit burning material or hot ashes on grass, plants or in refuse receptacles
- e. No person in a park shall build a fire at a time or period when the Director has prohibited the building of fires

**Ohio Fire Code: Open Burn recommendations:**

- a. All recreational fires in public parks shall be contained within a fire ring
- b. Fire ring must be a minimum of 15' from a structure or combustible material
- c. Only clean, dry wood shall be burned
- d. A means of extinguishment (fire extinguisher, bucket of sand, water, etc.) shall be present
- e. Adult supervision shall be present at all times
- f. All fires shall be completely extinguished when not in use
- g. If a recreational fire creates a nuisance, the Fire Department will require the fire to be extinguished
